As part of the Local Government Reorganisation, Essex, Thurrock and Southend made a submission to the government, which was accepted, to cancel the May 2025 elections. Leaders are meeting to work out how to divide Essex. There will be a public vote in May 2026 for the Mayor of Essex.

At the recent Local Plan meeting at Charter Hall representatives provided local knowledge to state the impact of the plan on residents. The councillors voted not to approve the draft local plan until the infrastructure plan is in place. There are water and sewage capacity issues, not enough buses and many other issues. Planning officers are saying it will take nine months to put a plan in to place.

- b) To review the budget to 31 March 2025 the clerk advised expenditure for the year was below budget by £5839, although payments due for 2024/25 of £1231 were due by 31 March 2025 but paid after 31 March 2025, making the underspend around £4600. This was due to no capital expenditure in the year, fewer payments for grass cutting than expected and a general underspend on estimated costs over the year. Income was more than expected due to grants kindly made by our Essex County Councillor Kevin Bentley for works at the play area, and from Cllrs Robert Davidson and Carl Powling towards a new village sign.
- c) To note the bank reconciliation to 31 March 2025 noted and agreed
- d) To agree the insurance premium for the year commencing 1 April 2025 of £601.34 noted and agreed
- e) To agree the Colchester City Council bin emptying contract/play area inspections for the year commencing 1 April 2025, at a cost of £681.15 noted and agreed
- f) To note the end of year actions the clerk advised that the end of year accounts and annual return were in progress and would be submitted to the Internal Auditor this week.
- To provide an update about the plans for VE Day 80 celebrations Cllr Neil Gordon and Ian Chamberlain will light the beacon at 9.30pm on Thursday 8th May 2026, to commemorate VE day 80.

Cllr Chamberlain agreed to check the play area fence, rake the bark even, clean the rockers, weed the area and cut the tree back that is on the perimeter of the fence.
