> Cllr Parsons advised that when the last Local Plan was developed Colchester City Council and Tendring District Council agreed to a garden community on their borders with 7500 houses. The intention was to have a low traffic neighbourhood and a link road to the A133 and A120 and a rapid transport scheme, funded by the government. This has been part built but the government funding has been withdrawn and the promised infrastructure before the build has not happened.

Chief Inspector Michelle Sparks is the new District Commander of the Colchester District of Essex Police, and is keen to engage with local councils.

- 096/25 To consider a quote of £210.00 from Colchester City Council for maintenance to equipment at the play area following discussion the quote was agreed by the Council
- 097/25 To consider adding commemorative plaques to the beacon for each event it is lit for following discussion it was agreed to add plaques to the beacon for each celebration. The clerk will organise backdated plaques for the events that have taken place

- O99/25 To consider quotes for a replacement bench outside the play area, funded by S106 monies, (costs approx. £650 plus removal of old bench and fitting new bench) following discussion it was agreed to leave the existing bench in place and put another bench on the recreation ground, location to be agreed.

- To discuss sending a letter to Colchester City Council regarding the draft local plan village envelope the clerk has contacted Abberton & Langenhoe Parish Council, as the other Parish affected by the draft local plan, and agreed to send the same letter as them to the City Council to address the Councils concerns
- To confirm the new date for the September meeting as Tuesday 16th September this date was confirmed to accommodate the clerks annual leave and councillors absences

 - Footpaths nothing to report
 - Village Pond the weed has recently been cleared
 - Recreation Ground Cllr Gordon reported to the clerk that he had cleared up rubbish and weeded the play area. One post in the car park is rotten and it was discussed whether this was due to strimming and if weedkiller would be a better option, with the consensus being to continue strimming. There is rubbish in the adjacent copse which will be reported to the owner

 - Fingringhoe School nothing to report

 - Tree Preservation Order the recent application for a TPO on the old oak on Church Green has been rejected by Colchester City Council as it is already protected by being in a conservation area
 - Village name stone now completed and the clerk to arrange delivery
 - Salt Bag Partnership more road salt will be requested
 - Football clubs another local team has requested to play on Wednesday evenings. The Council agreed this on an informal basis
 - Ferry Road bin a replacement rubbish bin (that dog waste can also be put in) will be provided by CCC
 - Recreation gates these are opened and closed by volunteers
