Cllr Bentley explained the government devolution route, confirming Essex will have an elected Mayor in May 2026. Also the local government reorganisation which will dissolve the existing councils and there will be 3 to 4 unitary councils that will look after everything.

Cllr Bentley will arrange a meeting in Birch for all his parishes to attend. There is £25 M already in the budget for Highways and another £30M for next year.

Also a huge increase in Special Educational Needs (SEN) provision in schools needs to be met.

Cllr Powling

It is likely our unitary Council will be Colchester, Tendring and Braintree, and Thurrock will be with Basildon and Southend with Castlepoint.

Call for sites - anyone can put in a site, whether they own it or not. However, just because you get planning permission for a site it doesn't give you the legal permission to build. Middlewick in Colchester might get SSSI (Site of Special Scientific Interest) status.

Martin Parsons

Before Christmas there was a change in planning law and the government stated there needed to be another 1.5M homes, and advised they would intervene if building is resisted. The imposed building targets in the Colchester area were increased by 40%.

This means 1300 homes must be built every year. The draft Local Plan mostly put the developments in rural areas where the infrastructure is poor, such as Langham who have 900 extra homes planned in a village of only 400 homes.

In this area the numbers are smaller, such as Langenhoe who are due to get 50 new homes. See item 11 below for more information

Cllr Ketley left the meeting.

Call for sites – one of the main issues is sewage. It was hoped that the water consultations would be carried out before the housing allocations. The interim report is concerning as it states that homes are using 20% less than they actually do and is already over capacity.

The Clay Barn site was not on the final Call for Sites list. Concerns were raised that that small development will join two settlements and that it would be difficult for the Council to comment on future developments.

The local plan committee on 17 February voted by a majority NOT to approve the draft local plan prepared by planning officers going out to public consultation yet.

The reason for this was primarily, that there was no plan of what infrastructure would be needed to go with the 1,300 new houses a year the government have told Colchester City Council they must build, nor the cost of this, or a plan for delivery of it.

There will be a delay of around 3 months, for the infrastructure plan to be drawn up, at which point it will go back to the committee to approve it going out to public consultation, and meet the February 2026 deadline before the current local plan expires.

The Local Plan does not give planning permission for housing, it just decides the sites. The City Council must demonstrate that they have a 5 year housing supply
