- To agree the size, cost, materials and location for No Cycling signs for the John
  Brunning Walk. Following discussion, it was agreed to order two more signs the same as the existing ones. Also to ask East Donyland Parish Council to put some at their end of the path
- To note the latest play area inspection and consider any actions required the clerk confirmed that the City Council inspector had advised that the report was up to date and showed that the items had been actioned. No further action is required as all risks were noted as Very Low Risk or Low Risk apart from the fence line, which has been strengthened from the other side.
- 130/25 To receive reports from Parish representatives
  - Footpaths FP 12 is quite overgrown and will be reported
  - Village Pond some weed has recently been cleared away
  - Recreation Ground another grass cut is needed. The Birch tree near the play area is leaning and will be inspected.
  - Transport the new bus consultation does not affect the Fingringhoe buses.
  - Fingringhoe School the Council agreed to some laminated signs around the boardwalk on Church Green to remind visitors to take away their litter and fishing debris

- Beacon plaque the new plaque marking the VE Day celebrations will be put up shortly
- Boardwalk replacement still obtaining quotes
- Common Land awaiting further information
- Village name stone will be erected in the next few months
- Classic car show proposed date 13<sup>th</sup> June 2026 but in the early stages of planning
- Village envelope letter a reply has been received but nor further action needed until the public consultation
- VAS the clerk has been advised it was repaired but is still not working
